TUITION DISCOUNTS

FINANCIAL AID

- Catholic School Foundation - Must apply through Facts Grant & Aid
- Available to K2 – grade 8 students only
- Deadline to apply – April 1st.

PAY IN FULL

- Full tuition payment paid in full by September 20th.
- \$100.00 per child

HOME & SCHOOL ASSOCIATION REBATE

- For every thirty hours of service to the school.
- \$100.00 per child – once per school year.
- Example – 2 children 60hrs = \$200.00 rebate

ROCHE BROS - \$100.00 per student (Parishioners Only)

REFER A FRIEND PROGRAM

- For current families that recruit new students/families to SHS a tuition rebate may be applied to your tuition balance. This rebate will be a maximum of \$500 per family recruited based on your own personal payment plan with the school. There will be no cash rebates given. The rebate applies to the family recruited, not to the number of students recruited.

TUITION INFORMATION SHEET

Plan A: Two Payments

- Registration Fee: \$500.00 (deducted from tuition cost)
- Registration fee is due with application for incoming students.
- Re-Registration Fee: \$200 due in January, \$300 due in May.
- Seats are guaranteed with the deposit; once a class is filled all inquiries will be put on a wait list. Present students will be assessed a \$300.00 late fee if Re-Registration monies are not received by May 15th.
- Registration fees are non-refundable/non-transferable.
- Full payment of balance due by September 20TH.
- \$100.00 discount per child
- Payments may be made directly to Sacred Heart School.
- This option carries a \$50 processing fee

Plan B: Ten Payments

- Registration Fee: \$500.00 (deducted from tuition cost.)
- Registration fee is due with application for incoming students.
- Re-Registration Fee: \$200 due in January, \$300 due in May.
- Seats are guaranteed with deposit; once a class is filled all inquiries will be put on a wait list. Present students will be assessed a \$300.00 late fee if Re-Registration monies are not received by May 15th.
- Registration fees are non-refundable/non-transferable.
- Payments will be automatically withdrawn, on the 20th of the month, commencing in July and ending in April. This option carries a \$50.00 processing fee, which will be added to your July payment.

Each year, you will be automatically reenrolled in the plan you selected and incur the applicable enrollment fee and bank withdrawals for the plan until graduation or student withdrawal. Student withdrawals must be submitted to the school office in writing.

Information regarding tuition fees, tuition policy and contracts will be sent in April.

FINANCIAL AID

The deadline for all to apply for Catholic School Foundation aid through FACTS is April 1st. Available to K2 through Grade 8 students only.

No family will be considered for financial aid without **ALL** supporting documentation. (Tax Return/W2's) received by FACTS. The school has no responsibility in this regard
